



ONE DIRECTION 'PAPERRACE' CHALLENGE - TERMS AND CONDITIONS

1. Entry

1.1 These Terms and Conditions, together with all other information provided prior to submitting a contribution form part of the rules of entering the One Direction 'Paperrace' Challenge (the "Rules"). By submitting a photo, you agree that you have read these Terms and Conditions and agree that you will be bound by them.

1.2 If you are under 16 years old, you must ask the permission of a parent or guardian before submitting a photo and the Promoter may place restrictions on your photo where necessary or appropriate.

1.3 Employees and their immediate families of the Promoter (see section 4 below for details), companies within the Sony Music Entertainment group of companies and any of their subsidiaries and/or agencies associated with this competition are ineligible to enter. Any such entries will be invalid.

1.4 In submitting a photo, you confirm that you have written consent from any and all persons in the photo to include their image and that they agree to these terms and conditions. In the event of a person in the photo who is under the age of 16, you confirm that you have written permission from that person's parent or guardian to include their image and that they agree to these terms and conditions.

1.5 In submitting a photo, you waive the right to any fee, royalty or compensation for the use of your submitted photo on a worldwide basis.

1.6 In submitting a photo, you agree that the Promoter may reproduce your photo and/or image for use on any of its online or offline properties on a worldwide basis.

1.7 You will not create or submit any content that is unlawful, pornographic, obscene, defamatory, libelous, threatening, discriminatory, harassing, bullying, vulgar, indecent, profane, hateful, racially, culturally or ethnically offensive, or that encourages criminal conduct, or that gives rise, or potentially gives rise, to civil or criminal liability, or that violates any applicable laws, rules or regulations, or that infringes or violates other parties' intellectual property, publicity, or privacy rights or links to infringing or unauthorized content.

2. General Terms

2.1 The Promoter reserves the right to verify the eligibility of submissions and check their identity.

2.2 No refund will be made for the cost of any submission. The Promoter may refuse to accept submissions in the event of an entrant's fraud, dishonesty or non-entitlement under the Rules.

2.3 In the event of any fault, mistake, misunderstanding or dispute concerning the operation of any part of the challenge, the decision of the Promoter shall be final.

2.4 The Promoter and Sony Music group of companies are not responsible for network, telephone line or communication failures of any kind or for submissions that are incomplete, corrupted, incomprehensible or not received.

2.5 Sony Music assumes no responsibility for damages, losses or injuries that result from submitting a photo, provided that nothing in the Rules shall exclude or limit the Promoter's liability for death or personal injury caused by its staff or supplier's negligence or for fraud.

2.6 Sony Music is not responsible for any payment of any taxes or other costs associated with submitting a photo.

2.7 Sony Music reserves the right to cancel this challenge and to amend these Terms and Conditions without notice in the event of circumstances outside its control.

2.8 The Rules shall be exclusively governed by the laws of England and you irrevocably submit to the exclusive jurisdiction of the courts of England and Wales.
